

**RELEASE OF LIABILITY AND WAIVER,**  
**ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT**  
*(This document affects your legal rights. Read the document entirely before signing.)*

I, for myself and the participant, acknowledge the inherent extreme risk involved in the activities occurring in the Facilities, including injury from flying object, objects thrown, hit or moving at a high rate of speed, and injury from a blunt force trauma, exertion, increased heart rate, motion, height, lifting, bending, squatting, or rotation. I understand and acknowledge that these activities can result in serious injury, disability or death.

I, for myself and the participant, if other than me, voluntarily agree to assume all risk of personal injury to myself or the minor's listed below and to any damage to my personal property, whether or not under the supervision of the Owner. I, for myself and my heirs, executors, administrators, assignees, hereby knowingly and intentionally waive and release, and agree to indemnify, hold harmless and defend the Owner, its successors, assigns, officers, employees, owners, members, affiliated organizations, agents, builders, designers, and the Facilities, from all faults, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with the use of the Facilities, including those resulting in injury, death, damages, paralysis and illnesses suffered by me or my property ("Claims"), which may, in any way whatsoever, arise out of, or be related to or be connected with use of the Facilities and all equipment and/or apparatuses or in any way connected with my presence of the property of Owner. I will indemnify, hold harmless and defend Owner and any of Owner's members, employees, directors, officers or agents from any and all costs, expenses, or liability including, but not limited to, the cost of any settlement or judgment made or rendered against Owner and any of Owner's members, employees, directors, officers or agents, whether individually, jointly, or in solido with me, together with all costs of court or other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney fees. **This release shall be effective even through said loss, damage or injury or has resulted from the negligence, wrongful acts, omissions, breach of warranty or strict tort liability of the Owner or the other parties released.**

I acknowledge that all minors are in good health and have no physical limitations that would affect their safe use of the Facilities. I agree they will pay attention to the state of any equipment they may use, and advise members of the Owner if they do any damage or notice any damage. I certify they will abide by any rules and any future rules of the Facility, and if the Owner or its staff make a specific request or instruction to the, they will comply.

**I further hereby acknowledge and agree that I have read, understand and will at all times abide by this agreement. I understand that this release is a legally binding contract. No oral representations, statements or inducements apart from the above written agreement have been made. I expressly state that I have read, understood and am familiar with all its provisions and that I sign it of my own free will. I further expressly agree that this Release of Liability and Waiver, Assumption of Risk and Indemnification Agreement is intended to be broad and inclusive as is permissible by the laws of the State of Texas and that if any portion of this agreement is held to be invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.**
